11:30 a.m. 40/60 shot air pistol & rifle matches (MAP, WAP, PPP, PPR)

(preparation & sighting shots begin 15 minutes prior to match start time)

12:00 p.m. 46/60 shot air rifle (MAR, WAR)  
2:00 p.m. 46/60 shot air rifle (MAR, WAR)

**25 Meter Range:**  
8:00 a.m. Standard Pistol (STD)  
9:30 a.m. Sport Pistol (SP)  
11:30 a.m. Rapid Fire (RF)

**Sanctioning/Sponsor:** These matches are sanctioned by USA Shooting and sponsored by the AR&PC

**Rules:** Current USA Shooting and IPC Rules will govern PTOs  
NTCSC rules will govern PPR competitions  
Current NRA-USAS PROGRESSIVE-POSITION PISTOL RULES will govern PPP

**Eligibility:** USA Shooting membership is required to compete in these matches

**Classification & Categories:** Classifications and age categories will only be applicable to Paralympic, PPP & PPR  
Gender categories will be used in squadding air gun matches

**Targets:** Paper targets will be used

**Scoring:** Scoring for air gun competitions will be using the Orion scoring system  
Humans will score the 25m events

**Score Reporting:** PTO Scores will be reported to USA Shooting  
PPP & PPR events are not reported to USA Shooting

**Entry Fee:** PTO – 1<sup>st</sup> event \$20 with additional events \$15 each and PPP/PPR - \$10

**Protest Fees:** A protest fee of \$10 will be charged on all protests

**Shooting Mats:** Shooting mats will be provided
